PARENT/GUARDIAN AGREEMENT – ONE PER FAMILY

We are thankful for the privilege of sending our child to Calhoun Christian School. We realize that the Christian School is not a substitute for the home or church, but rather a support for the Christian home. We recognize that a child’s greatest potential can be developed when the home, church, and school are working together. **We agree to abide by the Student/Parent Handbook. We, as parents/guardians, also agree to the following:

Admission and Attendance – I am in agreement and support the school’s mission, statement of faith, and the spiritual, moral, and disciplinary standards of the school. I understand that the school has full discretion for the grade placement of my child. I will do my best to insure that my child arrives at school on time each day. I further agree to see that my child maintains regular attendance.

Academic – I agree to support the academic program and standards of CCS and will assist at home by supervising assigned homework and by keeping in regular contact with my child’s teachers.

Spiritual – I understand that CCS requires regular attendance at a Bible-believing Christ-centered church. I agree to comply with this policy, and recognize that failure to comply may result in my child’s expulsion from the school.

Discipline – I agree that CCS has the authority to discipline my child as necessary. I agree to cooperate with the school by disciplining my child at home. I agree that the school has the right to expel any student who does not cooperate (or whose parents do not cooperate) with the total educational process, and that the school does not tolerate profanity, disrespect, gossip (from students or parents) or any other conduct that dishonors God or His Word. I understand that students may be disciplined or expelled by the school if, during in-school hours or off-school hours, they engage in conduct that violates biblical principles, dishonors God, is illegal, or casts a poor reflection on the name and reputation of the school.

Volunteer- I agree to complete 20 hours per family of volunteer service at CCS each year, not including transportation for school activities except for field trips.

Financial – I agree to pay the tuition and other necessary charges as billed. I agree that, if delinquent, I will pay all late and collection fees, including legal fees, if necessary. I understand that when a student is withdrawn or expelled, the current semester’s charges are due and payable. I also understand that assessments will be made if my child is responsible for damage to any school property.

Disagreements – I agree that all of our family members’ disputes involving or affecting CCS shall be settled privately because the Bible states that disputes among the believers shall be handled amongst ourselves and not in the secular courts (1 Corinthians 6:1-8). I agree to indemnify and hold CCS, its employees, and its volunteers harmless for all tort claims brought by on behalf of my child as a result of any action or inaction taken by the school, its employees, or its volunteers. Indemnification shall include the payment of actual attorney fees and costs.
